The scope of work includes site demolition, grading, site utilities, new parking lot, sidewalk, curb and gutter, landscaping and construction of a new community center.

Bids will be binding for a period of sixty (60) calendar days from the date bids are opened. All bids are to be accompanied with a bid bond, certificate of deposit, irrevocable letter of credit or certified check for five (5%) percent of the base bid. Bids are to be submitted on the Form of Proposal provided and in strict accordance with the Instructions to Bidders Section of the Project Manual for this project. All bids must comply with the laws of the State of South Carolina.

Individual bids must be clearly marked “Richland County Recreation Commission NEW PERRIN-THOMAS COMMUNITY CENTER” with the package number being bid (A) Solicitation #BL003-3L2-014. Bids shall be accepted by the Richland County Recreation Commission, 7473 Parklane Road, Columbia S.C. 29223 until 3:00 p.m., local time, November 13, 2014. Bids will not be accepted after the above date and time. The Richland County Recreation Commission encourages bids from minority firms.

A Pre-Bid Conference will be held at the Adult Activity Center, 7494 Parklane Road, Columbia, South Carolina at 3:00 p.m., local time, October 30, 2014.

Richland County Recreation Commission encourages participation by minority businesses to submit bids for this construction project. The Owner shall award public contracts without regard to race, religion, color, creed, national origin, sex, age or handicapping condition.
