I. SCOPE OF SOLICITATION

ACQUIRE SERVICES

The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions. [01-1010-1]

Awarded contractors shall furnish all labor and materials to provide swimming pool maintenance services to four (4) of Richland County Recreation Commission swimming pools.

Successful Bidders shall have a minimum of (2) year's commercial experience working on a contract or project of this size or larger.

MAXIMUM CONTRACT PERIOD - ESTIMATED (Jan 2006)

Start date: 04/15/2020 - End date: 04/14/2021. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract - Effective Date/Initial Contract Period". [01-1040-1]

This contract is for an initial term of one (1) year with the possibility of two (2) additional, one (1) year renewals.

II. INSTRUCTIONS TO OFFERORS

The scope of work for pool maintenance shall include pool opening, closing/winterization of pool, pump repair and other repairs as requested, monthly inspections, reports between pool closing and opening and a minimum of one (1) visit per week, per location. RCRC requires regular maintenance service on its swimming pools. This service will ensure each pool maintains the proper chemical control, temperature and is safe for continual use during the peak operating season. The awarded vendor shall provide a professional level of maintenance and monitoring services for all pool locations. The vendor will also provide all required labor, parts, and material requested in this IFB.

1. Pool Opening

(a) The Contract shall inspect the pool within the month of April of each season and submit a written report to RCRC listing any additional services, repairs, or equipment not covered herein which may be necessary to render the pools and filter systems operational. Such reports shall include a price quotation for any additional equipment and/or required services. RCRC shall either elect to employ the Contractor to provide these services or assume full responsibility for the completion of the additional items itself. If RCRC elects to provide the necessary repairs, the work will be performed in a timely manner, giving the Contractor ample time to open the pools by the date scheduled for opening.

(b) Prior to stated pool opening date, the Contractor shall provide the following services:

- (1) Remove pool cover.
- (2) Reassemble bathhouse and pool's freshwater system; check for proper operation and advise RCRC of needed repair(s), if any.
- (3) Chemically treat and remove debris from pool by power vacuuming.
- (4) Fill pool to proper level.
- (5) Store and utilize necessary chemicals.
- (6) Place filtration and chlorination system in operation. Check for proper operation and advise RCRC of needed repair(s), if any.
- (7) Install ladders, handrails, lifeguard chairs, skimmer lids, and safety rope.
- (8) Clean bathhouse and pool area.

- (9) Check for proper filter operation; maintain filter once determined to be in proper operation conditions. Vacuum clean pool prior to opening date.
- (10) Cooperate with any contractors in readying pool for operations.
- (11) Arrange for and be present at any local or state Health Department pre-opening inspection which may be required.

 - iii. Paint interior and exterior of bathhouses, if required.

- (s) Add all necessary chemicals to maintain proper alkalinity, calcium, water hardness, and conditioner levels in order to maintain pool water chemistry within National Swimming Pool Foundation (NSPF) and Richland County Guidelines.
- (t) Order all necessary chemicals from a chemical supplier of choice to maintain proper Chlorine and pH, Alkalinity, Calcium Hardness, and Conditioner levels. Contractor will be responsible for providing their own test kits and reagents.
- (u) Monitor chlorine and acid tanks levels and advise RCRC of any substantial changes in chemical demand. (i.e. increase in chlorine demand during summertime).
- (v) Manually test auto-fill device in surge pit ensuring proper working order. Clean surge pit and pre-pump strainer basket of all debris to ensure adequate water flow.
- (w) Visually check gauges on automatic backwash controller and sand filter(s) for correct operating pressures. Take corrective action as necessary.
- (x) Perform preventative maintenance on pool equipment to include monthly cleaning of chemical controller probes, monthly cleaning of chlorine injector, monthly inspection and testing of chlorine and acid suction and discharge lines.
- (y) Vacuum pool as needed, (Weekly at minimum).
- (z) Brush pool floor and walls as needed, (Weekly at minimum).
- (aa) Maintain Daily Chemical Readings Log and report as necessary.
- (bb) Complete minor equipment repairs.
- (cc) Complete all adjustments and calibrations as necessary to ensure proper pool operation including disassembly and reassembly of components requiring cleaning.
- (dd) Notify assigned RCRC representative of any needed repair, replacement, or service work that falls outside the scope of this IFB. The vendor will obtain approval for completing such work in advance.
- (ee) Labor costs incurred outside the scope of this IFB will be paid at the current Prevailing Wage.
- (ff) Repair costs shall start from the time of arrival on site. Repair costs will not include reimbursement of travel time expenses.
- (gg) Perform, as needed, the following deck maintenance:
 - 1) Check ladders, handrails, and bleachers and report any needed repairs.
 - 2) Check safety signs and safety equipment on pool deck.

3. Closing and Winterizing the Pools

- (a) On the last day of pool operations for each season, the Contractor shall be required to perform the following services in connection with closing and winterizing the pools:
 - 1) Shut off fresh water supply to the pool and bathrooms; disconnect piping at fixtures as required and drain all piping which can be drained.
 - 2) Add antifreeze to toilet bowls and tanks, urinal and sink traps, as required.
 - 3) Remove and place in storage all pool ladders, handrails, lifeguard chairs, skimmer lids, safety rope, and other loose equipment.

- 4) Drain pool to approximately twelve (12) inches below the rim. RCRC is then responsible for maintaining proper water levels.
- 5) Open all valves in filter room which require opening.
- 6) Backwash and drain filter tank and filter piping.
- 7) Store chlorinator, chemical feeders, and flow meters, as necessary, on premises.
- 8) Store pool maintenance supplies and testing equipment.
- 9) Store all pool deck furniture in bathhouse.
- 10) Cover pool with pool cover.
- 11) Submit to RCRC Recreation Superintendent a detailed inspection report covering condition of the pool facilities and related equipment.

4. Safety Equipment

(a) RCRC will provide a swim hook, backboard, ring buoys, safety rope, and first aid kits only. Pool ladders, handrails, furniture, and lifeguard chairs will be on site at the pools. The Contractor will be responsible for providing all other safety equipment as required by OSHA and other standard requirements for lifeguards needed for the safe operation of a swimming pool.

(b) RCRC will be responsible for providing all cleaning supplies such as cleaners, disinfectant, broom, mops, buckets, trash containers, paper products and any other equipment/supplies related to cleaning the pool, deck, bathroom facilities, etc.

(c) The Contractor shall provide and have accessible on the site all safety materials required for protection during handling of pool chemicals. These items will include chemical gloves, protective apron, safety goggles and respirator mask.

5. Inclement Weather/Emergency Shutdown: RCRC and/or the Contractor may close the pool facility in an emergency or during inclement weather. The Contractor will notify RCRC immediately of closing due to inclement weather, mechanical failure, or other conditions outside the Contractor's control. If the pool fails to open on its scheduled opening date or is closed during the pool operating season due to mechanical failure, inclement weather or responsibility outside of the Contractor's control, there will be no charge or adjustment in the compensation to the Contractor. If the pool is closed for a period of more than three (3) consecutive days because of mechanical failure, or the necessity of extensive repairs, inclement weather, or the order of any local or state regulatory body for any reason, RCRC will not be charged the daily maintenance fees for those dates of closure.

6. Contact Person: The contact person for RCRC will be the Recreation Superintendent, or other staff as approved by RCRC. The successful Contractor will be required to provide one contact person to represent his/her company, as well as phone number, etc. and at least one assistant. Contact person(s) and telephone number should be included in the proposal.

7. Responsibility of RCRC

(a) RCRC will be responsible for ordering and obtaining all supplies such as cleaners, disinfectant, broom, mops, buckets, trash containers, paper products and any other equipment/supplies related to cleaning the pool, deck, bathroom facilities, etc. Pool ladders, handrails, furniture, and lifeguard chairs will be on site at the pools.

(b) RCRC will provide personnel to secure safe entry to the pool facility.

- (c) RCRC will recruit and hire schedule swim instructors.
- (d) RCRC shall provide water, electricity and gas (if required) for the operation of the pool.
- (e) RCRC shall provide pool managing staff and lifeguards.

(d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. Subject to the conditions below, RCRC, providing a (30) thirty-day advance written notice is given to the vendor, may terminate the contract for any reason. **NON-APPROPRIATIONS:** Any contract entered by RCRC resulting from this bid invitation shall be subject to cancellation without damages or further obligation when funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period or appropriated year. **FOR CONVENIENCE:** If this contract is terminated or canceled upon request and for the convenience of RCRC without the required thirty (30) days advance written notice, then RCRC may negotiate reasonable termination costs, if applicable. **FOR CAUSE:** Termination by RCRC for cause, default or negligence on the part of the vendor shall be excluded from the foregoing conditions; termination costs, if any, shall not apply. The thirty (30) days advance notice requirement is waived and the default clause in this bid shall apply. **DEFAULT:** In case of default by the vendor, RCRC reserves the right to purchase any or all items in default in the open market, charging the vendor with any additional costs. The defaulting vendor shall not be considered a responsible bidder until the assessed charge has been satisfied.

TERMINATION DUE TO UNAVAILABILITY OF FUNDS

Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefor. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting

unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

THIRD PARTY BENEFICIARY

This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. WAIVER

The County does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Manager has actual authority to waive any of the County's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

VII. TERMS AND CONDITIONS

B. SPECIAL

BANKRUPTCY – GOVERNMENT INFORMATION

(a) All government information (as defined in the clause herein entitled "Information Security - Definitions") shall belong exclusively to the State, and Contractor has no legal or equitable interest in, or claim to, such information. Contractor acknowledges and agrees that in the event Contractor enters proceedings relating to bankruptcy, whether voluntary or involuntary, government information in its possession and/or under its control will not be considered property of its bankruptcy estate.

(b) Contractor agrees to notify the State within forty-eight (48) hours of any determination that it makes to file for bankruptcy protection, and Contractor further agrees to turn over to the State, before such filing, all government information that is in Contractor's possession in a format that can be readily utilized by the State.

(c) In order to protect the integrity and availability of government information, Contractor shall take reasonable measures to evaluate and monitor the financial circumstances of any subcontractor that will process, store, transmit or access government information. [07-7B007-1]

CHANGES

(1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished

under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

(a) Richland County Recreation Commission and the officers, officials, employees and volunteers of any of them, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.

(b) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects to the County and the officers, officials, employees and volunteers of any of them. Any insurance or self-insurance maintained by RCRC or the officers, officials, employees and volunteers of any of them, shall be excess of the Contractor's insurance and shall not contribute with it.

(c) Prior to commencement of the work, the Contractor shall furnish the County with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by RCRC before work commences. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. RCRC reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.

(d) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify RCRC immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.

(e) Contractor hereby grants to RCRC a waiver of any right to subrogation which any insurer of said Contractor may acquire against RCRC by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation, but this provision applies regardless of whether RCRC has received a waiver of subrogation endorsement from the insurer.

(f) Any deductibles or self-insured retentions must be declared to and approved by RCRC. RCRC may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of

ability to pay losses and related investigations, claim administration, and defense expenses within the retention.

(g) RCRC reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances

(h) RCRC reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances.

CONTRACTOR PERSONNEL

The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

CONTRACTOR'S OBLIGATION -- GENERAL

The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact about all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

DEFAULT

(a) (1) RCRC may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;

(ii) Make progress, to endanger performance of this contract (but see paragraph (a)(2) of this clause);
or

(iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) RCRC right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Manager) after receipt of the notice from the Procurement Manager specifying the failure.

(b) If RCRC terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Manager considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public

enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to RCRC, as directed by the Procurement Manager, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Manager, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) RCRC shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Manager shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Manager shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Manager determines to be necessary to protect RCRC against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of RCRC, be the same as if the termination had been issued for the convenience of RCRC. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of RCRC, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

ILLEGAL IMMIGRATION

Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, or without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees. INDEMNIFICATION - THIRD PARTY CLAIMS – DISCLOSURE OF INFORMATION

Indemnitee's consent is necessary for any settlement that requires Indemnitee to part with any right or make any payment or subjects Indemnitee to any injunction.

(c) Notwithstanding any other provision, contractor's obligations pursuant to this clause are without any limitation whatsoever. Contractor's obligations under this clause shall survive the termination, cancellation, rejection, or expiration of the contract. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, or without regard to any clause regarding insurance.

- (e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed, all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35, Article 17 of the S.C. Code of Laws.

(2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

PRICE ADJUSTMENT - LIMITED -- AFTER INITIAL TERM ONLY

RESTRICTIONS ON PRESENTING TERMS OF USE OR OFFERING ADDITIONAL SERVICES

(b) Unless expressly provided in the solicitation, public contracts are not intended to provide contractors an opportunity to market additional products and services; accordingly, in performing the work, contractor shall not – for itself or on behalf of any third party – offer citizens or public employees (other than the procurement officer) any additional products or services not required by the contract.

(c) Any reference to contractor in items (a) or (b) also includes any subcontractor at any tier. Contractor is responsible for compliance with these obligations by any person or entity that contractor authorizes to take any action related to the work.

(d) Any violation of this clause is a material breach of contract. The parties acknowledge the difficulties inherent in determining the damage from any breach of these restrictions. Contractor shall pay the state liquidated damages of \$1,000 for each contact with a citizen or end user that violates this restriction.

TERM OF CONTRACT -- EFFECTIVE DATE / INITIAL CONTRACT PERIOD

The effective date of this contract is the first day of the Maximum Contract Period as specified on the final statement of award. The initial term of this agreement is 1 year from the effective date.

Regardless, this contract expires no later than the last date stated on the final statement of award. [07-7B240-1]

TERM OF CONTRACT -- OPTION TO RENEW

(a) At the end of the initial term, and at the end of each renewal term, this contract shall automatically renew for a period of 1 year unless contractor receives notice that RCRC elects not to renew the contract at least thirty (30) days prior to the date of renewal. Regardless, this contract expires no later than the last date stated on the final statement of award.

(b) Contractor acknowledges that, unless excused by Section 11-57-320, if the contractor is on the then-current Iran Divestment Act List as of the date of any contract renewal, the renewal will be void ab initio. [07-7B245-2]

TERM OF CONTRACT -- TERMINATION BY CONTRACTOR

Contractor may terminate this contract at the end of the initial term, or any renewal term, by providing the Procurement Manager notice of its election to terminate under this clause at least 160 days prior to the expiration of the then current term. [07-7B250-1]

TERMINATION FOR CONVENIENCE -- INDEFINITE DELIVERY / INDEFINITE QUANTITY CONTRACTS

Unless the termination so provides, a termination for convenience shall not operate to terminate any purchase orders issued prior to the effective date of termination. [07-7B255-1]

TERMINATION FOR CONVENIENCE

(1) Termination. The Procurement Manager may terminate this contract in whole or in part, for the convenience of the State. The Procurement Manager shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective.

(2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Manager may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to RCRC. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

(3) Right to Supplies. The Procurement Manager may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Manager: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Manager, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Manager does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in an accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that RCRC has breached the contract by exercise of the Termination for Convenience Clause.

(4) Compensation.

(a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Manager may pay the contractor, if at all, an amount set in accordance

with Subparagraph (c) of this Paragraph.

(b) The Procurement Manager and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated;

(c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Manager shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph:

(i) contract prices for supplies or services accepted under the contract;

(ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;

(iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;

(iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.

(d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.

(5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the state's right to require the termination of a subcontract, or (ii) increase the obligation of the state beyond what it would have been if the subcontract had contained an appropriate clause.

NONRESIDENT TAXPAYER REGISTRATION AFFIDAVIT INCOME TAX WITHHOLDING

IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation.
